In consideration of being allowed to participate in any way in the Amelia Island Last Leg Rally, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from the activities involved in the associated events and activities may be significant and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist: and

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISK, both known and unknown. EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation: and I willingly agree to comply with the stated and customary terms and conditions for participation. If however I observe any unusual potential hazard during my attendance or participation in any LLR event or location, I will remove myself from the participation and bring such to the attention of the nearest official immediately: and I for myself and on behalf of my business, company, heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE AND HOLD HARMLESS Amelia Island Last Leg Rally, Anchors Away Charters Inc., and the City of Fernandina Beach, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable owners and lessors of premises used to conduct any and all associated events or activities ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY WHETHER ARISING FROM NEGLIGENCE OF THE RELEASEE OR OTHERWISE.

3. LEGAL COMPLIANCE/TAXES- Vendor agrees to comply with all State & Local Laws, Licensing, Permits, and health department regulations. Vendors are solely responsible for payment of local & State sales tax due as a result of any sales made during this event.

4. INSURANCE/HOLD HARMLESS- All Vendors & Exhibitors must provide proof of valid business liability insurance. Vendor is solely responsible for all dealings and actions, and holds LLR harmless from all claims. Further, Vendor shall carry liability insurance in a form and issued by a company satisfactory to LLR, which shall name the City of Fernandina Beach, the Last Leg Rally and Anchors Aweigh Charters, Inc. as additional insured's and certificate holders for the period of the Vendor's operation at the LLR.

Coverage shall be a minimum of \$1,000,000 ea. occurrence/personal injury and \$2,000,000 general aggregate. A copy of the Liability Certificate showing the additional insured(s) / certificate holder(s) must be provided to LLR by your insurance company and on file prior to application acceptance. 5. SECURITY- Vendor is responsible to secure his own property and to ensure it is properly stored daily. LLR is not responsible for damages for losses by fire, theft, or any other cause.

6. SET UP & BREAK DOWN- Vendors must check in with the Vendor Chair before beginning set up to receive their assigned spot. Large vendors that need to set up on Friday can check in between 12 noon and 4pm on Friday. If you do not check in by 4pm you have to wait until Saturday morning. There is a Meet and Greet at another location on Friday night. All Tents must be weighted and not staked. (If anyone breaks a water line they will be responsible for damages.) Vendors & Exhibitors may set up at first light Saturday morning if they have already checked in with the Vendor Chairperson. All vehicles must be removed from the Rally Vendor/Display area by 8:30am, Saturday. The Rally officially opens to the public at 9:00am, Saturday. Vendors must keep their booth area staffed at all times while the Rally is open (Sat.-9:00am-6:00pm / Sun.-9:00am-6:00pm). No Vendor may begin break down or depart prior to the close of the Rally at 6:00pm on Sunday.
